

## **UNC-CH Faculty of Color and Indigenous Faculty Group Statement on Faculty Governance**

Statement from Members of the UNC-Chapel Hill Faculty of Color/Indigenous Faculty (FOC/IF) Group

We have noted, with concern, media reports about attempts to usurp and replace our university's Chancellor, Dr. Kevin Guskiewicz. We strongly oppose any efforts to remove our campus leader, without any input, whatsoever, from our faculty, staff, students, and other members of the Carolina community. Such interference flies in the face of long-standing principles of shared governance at UNC-Chapel Hill.

As stated on our Faculty Governance website, “[s]ince the University of North Carolina opened its doors in 1795, faculty have shared responsibility with a Board of Trustees for running the campus. Principles of shared governance and best practices for keeping strong the faculty voice in university policy-making were articulated as early as 1920, when the American Association of University Professors published its first statement on shared governance between faculty, administrators, and trustees.”

We urge the UNC-System Board of Governors and the UNC-Chapel Hill Board of Trustees to honor the long tradition of faculty governance at UNC-Chapel Hill and refrain from any unilateral action to remove Chancellor Guskiewicz.
